### REGULATIONS

1. Rental will be cancelled and deposit forfeited if all fees are not received in full, 2 weeks before the rental.
2. \$50.00 security deposit is required within two weeks of making the reservation for the facilities; refunded after the rental if no damages incurred and no regulations are broken. Deposit will not be refunded if the group cancels the rental with less than 24 hour notice.
3. A full refund will be granted for rentals cancelled due to weather or mechanical problems. If these problems occur after the rental has started the refund will be prorated.
4. Groups must have at least two sponsors, ages 21 or older, present throughout the entire rental.
  - o Parties with children under the age of 7 years old must have one sponsor for every four children.
  - o For parties with children ages 7- 9 years old there must be one sponsor for every eight children.
  - o Parties with kids 10 years and older must have one sponsor per ten children.
5. No Alcoholic beverages may be served and smoking is not permitted.
6. Individuals renting the pool may not collect any revenue from participants while on the premises.
7. Rentals must adhere to all pool regulations see the attached pool regulation sheet.
8. Youth parties (13-20 year olds) require police coverage at an additional \$30 per hour.
9. Parties with children under the age of eight must have one adult in and out of the water for every four children under the age of seven.
10. Renter is responsible for the conduct of everyone in their party at all times during the pool rental.
