

SRSNLC's Story

SRSNLC is a cooperative agreement between the Lindenhurst, Round Lake, Waukegan, and Zion Park Districts. This organization provides recreation and leisure services for people with special needs.

Special Recreation Associations are able to exist due to a law unique to the state of Illinois, which allows any two or more park districts to form what has become known as a Special Recreation Association (SRA). Many other SRA's exist in the Chicago suburban area. A professional organization called the Participant Services Division of the Illinois Therapeutic Recreation Services (PSD/ITRS) has been formed out of an interest by SRA's (including Waukegan) to share common problems and solutions, and to promote recreation for special populations on a wider scale.

SRSNLC-Waukegan was formally known as Waukegan-Foss Special Recreation Association. WFSRA was formed in early 1980 through an agreement with Waukegan and Foss Park Districts. In 2000, WFSRA dissolved. Waukegan Park District joined Lindenhurst, Round Lake and Zion Park Districts to create a new agency, Special Recreation Services of Northern Lake County (SRSNLC)

SPECIAL RECREATION SERVICES OF NORTHERN LAKE COUNTY (SRSNLC) WAUKEGAN

Several local Park Districts joined together to form SRSNLC in an effort to better serve the people of Northern Lake County. Waukegan is one of the towns that joined this cooperative effort. Prior to that it had been associated with the Waukegan-Foss Special Recreation Association (WFSRA).

SRSNLC specifically serves residents who may have a disability, regardless of severity or nature, and facilitates those residents' inclusion into their home community leisure programs whenever feasible.

It employs one to three full time staff members who have college degrees in Therapeutic Recreation, are nationally Certified Therapeutic Recreation Specialists, and have professional accreditation.

Waukegan Special Recreation offers year-round programming in a variety of areas. It depends greatly on the services of its many volunteers and seasonal staff to deliver these leisure opportunities. The Waukegan office is located at Upton Park, 732 North Genesee Street.
