PLEASE MAKE NOTE OF THE CHANGES AND CLARIFICATIONS: USE ATTACHED PRICE SHEET

1. Change:

Original electrical drawings indicated a three wire grounding NEMA L9-20 twist lock plug and receptacle were used at each light. Sheet note #1 incorrectly indicates existing twist lock plugs and receptacles are three wire grounding NEMA L9-20 and that pendant rewiring will be required. Existing plug and receptacle are five wire grounding NEMA L23-20 twist locks. Rewiring inside existing pendant is not required. Circuits will need to be adjusted in the junction box at the deck per the new plan.

2. Change:

Electrical contractor to provide an additional alternate bid #3 price for type A3 and B3 lights. Type A3 light shall be Lithonia JHBL-30000LM-ACL-WD-120-GZ10-40K-80CRI-SF-WGX-DWHXD-HCX. Type B3 light with emergency battery pack shall be Lithonia JHBL-30000LM-ACL-WD-120-GZ10-40K-80CRI-SF-BSL722C-WGX-DWHXD-HCX. Include safety cable. Add conduit nipple and coupling to adjust height of hook so bottom of light is at approximately the same height as the existing light fixtures.

3. Change:

Electrical contractor to provide additional alternate bids #4 thru #7 for completing work at night instead of during the day.

Alternate bids are as follows:

Alternate bid #4: additional cost to install base bid type A and B lights during a night shift.

Alternate bid #5: additional cost to install base bid type A1 and B1 lights during a night shift.

Alternate bid #6: additional cost to install base bid type A2 and B2 lights during a night shift.

Alternate bid #7: additional cost to install base bid type A3 and B3 lights during a night shift.

Gym available from 10 p.m. to 6 a.m. or later. Up to two courts may be worked on during the day until 4 p.m. By 4 p.m. all courts need to be operational.

4. Change:

Construction completion date extended to November 3rd.
