CHAPTER 9 - AMENDMENTS

WAUKEGAN PARK DISTRICT
AN ORDINANCE REGULATING THE USE OF
THE PARKS AND PROPERTY
OWNED OR CONTROLLED BY
THE WAUKEGAN PARK DISTRICT

WHEREAS, the Waukegan Park District is an Illinois Municipal entity operating within territory predominantly in the city of Waukegan, Lake County, Illinois; and

WHEREAS, it is reasonable, necessary and desirable for the District to establish rules and regulations in order to provide for the safe and peaceful use of its parks; and

WHEREAS, it is reasonable, necessary and desirable for the District to establish rules and regulations in order to provide for the government, protection and preservation of the property, facilities and resources of the parks; and

WHEREAS, the Board has determined that it has become necessary and desirable to update the prior Ordinance Regulating the Use of Parks and Property Owned or Controlled so as to clearly reflect changes in law, circumstances and the needs of the Park District; and

WHEREAS, the Board has determined it is in the best interests of the District to adopt the attached ordinance, being Exhibit "A" in its entirety, and incorporated herein as if full set forth as the Ordinance Regulating the Use of the Parks and Property Owned or Controlled.

SECTION ONE: ADOPTION. That the provisions contained in the ordinance, being Exhibit "A," appended hereto and expressly made a part hereof, be and the same as hereby adopted as the "Ordinance Regulating Conduct in Public Parks" within the Waukegan Park District, Lake County, Illinois.

SECTION TWO: SEVERABILITY: The various provisions of this Ordinance are to be considered as severable and if any part or portion of this Ordinance shall be held invalid by any court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this ordinance.

SECTION THREE: REPEAL OF PRIOR ORDINANCES: All prior ordinances and resolutions in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

SECTION FOUR: EFFECTIVE DATE. This ordinance shall be effective immediately upon its passage, approval, and publication as provided by applicable law.
