

## What is a Special Recreation Association?

SRSNLC is a cooperative agreement between the Lindenhurst, Round Lake, Waukegan, and Zion Park Districts. This organization provides recreation and leisure services for people with special needs.

Special Recreation Associations are able to exist due to a law unique to the state of Illinois, which allows any two or more park districts to form what has become known as a Special Recreation Association (SRA). Many other SRA's exist in the Chicago suburban area. A professional organization called the Participant Services Division of the Illinois Therapeutic Recreation Services (PSD/ITRS) has been formed out of an interest by SRA's to share common problems and solutions, and to promote recreation for special populations on a wider scale.

Each Cooperative District of Special Recreation Services of Northern Lake County offers a variety of recreation programs throughout the year including bowling, swimming, crafts, cooking, team sports, Special Olympics training, social clubs, summer day camps and numerous special events.

Special Recreation strives for each participant to function at his/her highest level of ability in the least restrictive environment. If you are interested in Special Recreation programs or services, please call your local office at:

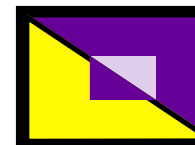

## SPECIAL RECREATION SERVICES OF NORTHERN LAKE COUNTY (SRSNLC)

In 2000, the Lindenhurst, Round Lake Area, Waukegan and Zion Park Districts entered into an intergovernmental cooperative agreement known as Special Recreation Services of Northern Lake County in an effort to better serve the people of Northern Lake County. Prior to SRSNLC's formation, the Lindenhurst, Round Lake Area and Zion Park Districts were collaborating as Special Recreation Association of Round Lake, Lindenhurst and Zion (SRARLZ), while Waukegan was part of the collaborative Waukegan-Foss Special Recreation Association (WFSRA).

SRSNLC specifically serves residents who may have a disability, regardless of severity or nature, and facilitates those residents' inclusion into their home community leisure programs whenever feasible.

Each member district employs full-time staff with college degrees in Therapeutic Recreation or a related field and depends greatly on the services of its many volunteers and seasonal staff to deliver a variety of year-round leisure opportunities.
