### Scope of Work

- 1. To furnish and install 1 Heating, Ventilation and Air Conditioning system as described in the following:
  - a. Reclaim refrigerant, disconnect roof top unit and haul away.
  - b. Supply and Install (1) Carrier 5 Ton cooling capacity gas heat packaged units.
  - c. (2) Carrier Model# 48TJE00<u>6</u>8, 5 Ton cooling, Gas Heat Vertical duct configuration. <u>Single phase 208/230v</u> (Serial# 2098G21218)
  - d. <u>410a</u>R134a refrigerant only to be used.
  - e. Replace thermostat with equivalent to existing.
  - f. Units to have economizers.
  - g. New unit to have 1 year parts warranty, 5 Year compressor warranty, 10 Year heat exchanger warranty.
  - h. New unit to sit on existing curbs.
  - i. Reattach electrical to unit reusing existing disconnect, reconnect gas and control wiring and add GFCI convenience duplex outlet adjacent to safety switch.
  - j. Install outdoor condensate traps.
  - k. One year Labor and Material Guarantee from date of startup.
  - I. Routine Maintenance not included.
  - m. Crane services to be provided by contractor.
  - n. All jobsite related debris to be removed from jobsite.
  - o. Provide operation and maintenance manuals/DVD and balance reports.
